From the Desk of the Director



Our new fiscal year has started with a big bang. For the first time in the history of our program we are fully staffed and the results have been almost instantaneous. Our newly on-boarded Volunteer Coordinator has been holding information sessions in the evenings and consequently we have just completed two training sessions for

12 new ombudsman volunteers -- the largest class of trainees we have seen in several years. These fine people are now completing the field internship portion of their training prior to us submitting their names to the state for certification as long-term care ombudsman. This is, of course, only the beginning, as it will take us a full two years to develop these new volunteers to become seasoned ombudsmen.

These are certainly exciting times for us. Ever since I joined the program 14 years ago, my goal has been to have 60 field ombudsmen (volunteers) monitoring facilities, receiving and investigating complaints. That may no longer be a pipe dream; I believe it could well become a reality. And when that happens we will truly be fully resourced.

October is Residents' Rights Month



What are Residents' Rights? -- In the USA personal rights are part of the very fabric of our society – embedded in bold letters in our constitution. Why then is it so important to emphasize residents' rights for National Consumer Voice For Quality Long-Term Care those in long-term care facilities?

Too often we see individuals admitted to facilities after a series of severe losses – loss of their home as they transition to long term care, loss of a loved one, loss of their health and/ or their independence, and the list can go on interminably. They arrive in trepidation, not knowing what awaits them, often having to share a room with one or more strangers.

All too often assumptions are made that they have lost some of their autonomy, rights they were accustomed to when living independently in their own homes. Not so. They retain all the same rights, including the right to vote, unless they are deemed to have lost competency (a medico-legal determination). The 1987 OBRA laws relating to nursing homes list the core residents' rights, and more recently a similar list has been encoded into law applying to residents in the residential care facilities for the ederly. An abbreviated, incomplete list follows:

- The Right to Be Fully Informed on a variety of issues and in a language they understand
- Right to Complain without fear of reprisal
- Right to Participate in One's Own Care to be a part of the care planning and treatment decisions, including the right to refuse treatment
- Right to Privacy and Confidentiality Private and unrestricted communication with any person of their
- Rights During Transfers and Discharge, including safe transfer or discharge through sufficient preparation by the nursing home
- Right to Dignity, Respect, and Freedom: to be free from mental and physical abuse, corporal punishment, involuntary seclusion, and physical and chemical restraints, to participate in group activities including residents' councils and to manage one's own financial affairs.
- Right to Visits, by relatives, friends, the resident's personal physician and by the ombudsman
- Right to Make Independent Choices, including reasonable accommodation of one's needs and preferences, choosing a physician, refusing treatment.



Resident's Rights: A Case Example





To celebrate Resident's Rights Month, community members and ombudsmen showed off their "Care Matters bracelets before the film screening of the Frontline Documentary "Being Mortal" on September 24.

A young man was admitted to the nursing home from one of the hospitals – a severe diabetic with a wound on one of his feet – a treacherous combination. While in the hospital the physician and the podiatrist assigned to him were quite adamant that they would need to amputate as a result of complications. This young man was equally as adamant that they would not be amputating any portion of his leg. He contacted his former podiatrist who attended to him in the hospital and the wound began to heal. The hospital discharged him for rehab to a nursing home where he was visited by a podiatrist that had a contract with the nursing home to attend to their residents – the very same podiatrist that had recommended amputation when he was hospitalized. The young man refused to see him. The nursing home explained that he was the only podiatrist who

was contracted to see their clients and therefore the only one who could come into the facility for podiatry needs. The young man called the ombudsman and explained the situation. Our ombudsman immediately visited the home to speak with the client, and was then able to sit down with the administrator to discuss residents' rights and that this young man had the absolute right to choose his own podiatrist. After some discussion and a review of the laws pertaining to residents' rights, the man made an appointment to visit his chosen podiatrist, the same one that had saved his leg from being amputated, and the nursing home was required to set up the appropriate transportation for him to do so. After many months the wound healed and the young man went home, back to his productive life in the community.
