JAY KATZ HONORED *as OSSMC Volunteer of the Year*

Jay Katz was honored with the 2019 Richard Rampton Volunteer of the Year Award at OSSMC's 2nd Annual Volunteer Recognition Luncheon in April at the Crowne Plaza Hotel in Foster City. The award is given in honor of the late Richard "Dick" Rampton to a field ombudsman who like him, was a tireless advocate for long-term care residents.

Additional awards were given for years of service, continued support, and for distinguished service *(see related story below)*.

Jay, an El Granada resident and social worker, is one of OSSMC's 40 trained ombudsmen. These volunteers visit San Mateo County's 462 long-term care facilities to investigate complaints that could be physical, sexual or financial abuse and involve facility workers or the family of residents.

"Jay is amazing," said Kirsten Irgens-Moller, OSSMC program manager. "He has a wealth of experience and he's just so caring and nurturing. He always goes the extra mile."

Jay's experience includes serving as a recreation leader and social worker for the Pomeroy Recreation and Rehabilitation Center in San Francisco. He has a master's degree in social work from San Francisco State University.

"I represent all the people who volunteer here," Jay said about the award. "I don't think I do anything special."

He added that he understands the challenges staff of long-term care facilities face and the important role they may play in the lives of residents.

Vic Lee, an award-winning reporter for ABC7 News and Master of Ceremonies at OSSMC's Volunteer Luncheon, and Mitchell Bailey, Vice Chancellor and Chief of Staff at the San Mateo County Community College District, have joined the OSSMC Board of Trustees.

Vic grew up in Tokyo, Japan. He attended San Jose State University, where he was Student Body President in 1968. Vic interned at the *New York Times*, then worked at United Press International in Portland, Tokyo and Los Angeles.

He later joined KRON-TV/NBC, traveling extensively in Asia to report on business, education and social issues. After 32 years there, Vic joined KGO TV/ABC7 News in 2006.

He has received numerous Emmys and other awards, including the New York Film Festival Gold Award for best documentary and the George Polk Award of Journalism for best local TV reporting.

"My mission as a journalist for nearly five decades, has always been to make a difference through my stories," Vic said. "I hope I can do the same as a board member for OSSMC by making a difference in the lives of our long-term care residents."

He has also worked in government operations at the Ohio Department of Administrative Services, leading several government-wide initiatives for the Governor's Office.

Locally, Mitchell is involved in various community and professional activities, including serving on the San Mateo Chamber of Commerce Board of Directors and as the District's representative to the Silicon Valley Leadership Group. He is also a graduate of the Redwood City San Mateo County Chamber Leadership program.

In 2015, Mitchell was named as one of the "Forty Under 40" business and community leaders by the *Dayton Business Journal*.

LONG-TERM CARE RESIDENTS Receive Knitted Blankets

For Diane Lewis, Alice's Embrace is a labor of love in honor of her late mother Alice Figueira who suffered from Alzheimer's disease and died in 2011.

Shortly after Alice was diagnosed with the disease, daughter Diane knitted her a soft green blanket that she would use in her assisted living apartment and later in the memory care unit.

"I often found the blanket draped over her lap while she was relaxing in her rocking chair," Diane said.

"Mom would intertwine her fingers through the stitches, and that's when I realized it had a soothing effect on her."

A few years later, Diane began knitting prayer shawls, lap blankets and full-size blankets for a daycare facility in Indiana. She wanted to bring her idea closer to home in California and launched a website for Alice's Embrace.

Others quickly began to knit or crochet items for those suffering from

Alzheimer's disease, and now hundreds of people from around the world donate their time to make something special for someone they don't even know. Some of those people knitted the blankets recently donated to OSSMC for 13 Alzheimer patients at San Mateo County's longterm care facilities.

"The whole concept behind Alice's Embrace is comforting the recipient, but the item's creator also receives joy knowing that their homemade gift is going to someone so deserving," Diane said.

Donors make lap blankets and prayer shawls following the 52 stitch patterns shown on the website. Each is named after a unique story about Alice.

A team of four to six people deliver these bright, warm and vibrantly colored gifts to memory care communities. Oftentimes, the resident gets to choose the one he or she likes, and his or her name is then written on the Alice's Embrace label.

"I look forward to sharing my experience and love of working with those 60 and better, their families and our communities," Vicki said.
